Employees' State Insurance Corporation is a statutory body under the Ministry of Labour and Employment, Government of India. The Employees' State Insurance Scheme, established under the Employees' State Insurance Act of 1948, is a comprehensive social security insurance program designed to provide social security to Insured Persons / dependents as defined by the Act, against the impact of contingencies of sickness, maternity, disablement and death due to employment injury and to provide medical care to insured persons and their families. The ESI Act is applicable to all non-seasonal factories and establishments as per notification of appropriate Governments. The ESI Act, 1948 applies to factories/establishment employing 10 or more persons. The employees of registered factories and establishments drawing wages up to Rs. 21000/- per month (Rs. 25,000/- for Persons with Disability) are covered under the Act. - 2. Scrutiny of Accounts for financial year 2025 -2026 keeping in view classification of

income and expenditure including verification of accounting adjustments/rectification of errors, omission in books of accounts and clearing suspense entries. All effort should be made to ensure that:

 - Assistance and training (if required) to resources deployed in concerned unit.
- Further, any other financial opinion/help/guidance/verification/vetting required/sought by Financial Commissioner and Director General, ESIC in any matter. Any other financial report and compilation required by financial division
- 12. The above scope of work is indicative in nature and may be enhanced / curtailed as per the requirements of the division.

<u>Report:</u>

The detailed report(s) of SRO Coimbatore will be submitted in single hard copy to the Administrative Head and the Finance head of ESIC, SRO Coimbatore. Further, the Administrative Head and the Finance head of ESIC, SRO Coimbatore forward the said report with analysis/findings and recommendations (if any) to Financial Commissioner/Additional Commissioner, ESIC Hqrs. Soft Copy of report with analysis/findings and recommendations (if any) has also to be submitted in MS Excel/Word through email to ac-fin@esic.nic.in. ESIC Hqrs may direct the Empanelled CA firm of SRO Coimbatore for any specific work or any detailed work report.

Penalties:

If the empanelled CA Firm there off is found guilty of gross negligence, lack of duty of care, misrepresentation and misstatement of facts, hiding the facts, falsification, undue delay in performance of duties, using or giving the details gathered during the assignment to other parties without permission of the ESIC, non-observation of instructions given by the ESIC, unauthorized retention of records of the ESIC, violating the terms and conditions of this assignment, indulging in malafide practices or any other cognizable offence or breach, the firm shall be punishable as deemed appropriate by the ESIC or in case of delay in carrying out the work, penalty at the rate.

Termination of Contract:

If service provider is found responsible for any leakage of information, lobbying, bribing etc., then ESIC have the right to terminate the contract and if required as per applicable law, action deemed fit may be initiated against the empanelled CA firm. Also, if cumulative penalties reaches 10% of contract value, competent authority may terminate the contract

Miscellaneous:

A. Sub-contracting:

The firm should not enter into sub-contracting with or hiring of any other vendor / firm for part / full of the Corporation work in any manner whatsoever. In case, a firm/ individual is required to be engaged for specialized professional/ creative assignment, prior written permission of the Corporation should be sought.

B. Confidentiality:

The firm shall maintain strict confidentiality of all the documents, information, data coming in knowledge and/or possession of the firm as a result of performance/execution of its obligations as per the contract and also any oral, written or other information disclosed for evaluation or for any other purposes shall be considered as confidential information passed on to the firm. Any staff violating code of conduct shall be replaced forthwith, besides a penalty on the firm as decided by the Corporation shall be imposed and repeated violations in this regard may lead to termination of the Contract as and when decided by the Corporation as per the procedure prescribed herein. This clause

relating to Confidentiality shall survive upon the termination/expiration of the Contract and the Corporation shall have right to claim damages for violation of this Clause within 02 years next after the termination/expiration of the Contract.

C. Use of data/ documents/information:

The firm shall ensure that the documents, data, information etc. are not used or permitted to be used in any manner(directly or indirectly) and shall not violate any of the direction or instruction as authorized by the Corporation. The information shall be safeguarded and the firm shall take all necessary actions to protect the Corporation's interest against misuse, loss, destruction, alterations of deletions thereof. Any violations of the same will be liable for action under the law which shall entitle the Corporation to claim damages from the firm apart from taking action under the applicable law. This is an irrevocable condition and it will continue to be in force up to two years after survive termination/expiry of the contract. This clause shall upon the termination/expiration of the Contract and the Corporation shall have the right to claim damages for violation of this clause within next after two years of the termination/expiration of the Contract.

D. Force Majeure.

Neither party shall be liable in respect of failure to fulfill its obligations, if the said failure is entirely due to force majeure, Acts of God, Governmental restrictions or instructions, natural calamities or catastrophe, epidemics or disturbances in the country. Force Majeure shall not include

- (i) Any event which is caused by the negligence or intentional action of a firm or by or of such firm's agents or employees, nor
- (ii) Any event which a diligent party could reasonably have been expected both to take into account at the time of being assigned the work, and avoid or overcome with utmost persistent effort in the carrying out of its obligations hereunder.

Force Majeure shall not include insufficiency of funds or manpower or inability to make any payment required for execution of services under this Contract. A Party affected by an event of Force Majeure shall immediately notify the other Party of such event, providing sufficient and satisfactory evidence of the nature and cause of such event, and shall similarly give written notice of the restoration of normal conditions as soon as possible. Unless otherwise directed by the Corporation in writing, the firms hall continue to perform its obligations under the contract agreement as far as reasonably practical and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

- **E.** The offer should be valid up to 90 days after closing date of Tender. Non- fulfillment of any of the above terms shall result in rejection of bid.
- **F.** All disputes lie within the jurisdiction of Coimbatore only.
- **G.** The Joint Director (I/c), ESIC, Sub Regional Office, Coimbatore reserves the right to reject all or any Tender without assigning any reason thereof.
